Progress report

I have spent £7200 of the money already and we have very little to show in the studio's!!!

Studio Two wiring interface for the computer is finished, Studio 1 is half done. When studio 1 is complete more than likely next Saturday. I have to get me skates on and do the new transmission rack in engineering.

Whilst I have promised a PC in the studios for the end of January I have two issue's to sort out before that happens 1 Training/notes and 2 Security of equipment.

New Transmission Rack

This rack will carry a digital sound analyzer which will modify all output from the studio complex before it leaves our premises. In addition an equalizer and distribution amp will be included. The rack will also carry two mixers for the rhapsody machine plus a radio tuner and Satellite receiver.

A piece of kit I have yet to build is also a silence detector which will provide a signal from the radio tuner should the pc fail.

I need the new distribution side sorted ASAP so that our link to the patient power control room is ready.

The new equipment on the transmission side will greatly enhance the quality of the stereo signal which will be sent and also the mono signal to the inductive loop am service.



There are only 74 days left before the first test transmission of the service takes place. As the days count down you have less and less time to create some of the items which have already been highlighted in earlier emails. If you intend to leave it till the last minute don't be surprised if your material is not included because their is only a finite time for us to coordinate and produce the final playlists etc.
